#### Commitment focused on customer satisfaction, through:

- The definition, formalization and dissemination of this Policy

- Communication with the customer and the community in order to understand their needs
- The design and construction of products in order to meet the needs of users
- Involvement, motivation and professional development of all personnel

- The definition and achievement of objectives for continuous improvement of one's performance to adapt to developments in the sector and the efficient management of one's processes in order to make the best use of company resources

- The maintenance of a Quality, Environment and Safety Management System capable of satisfying the requirements of the PED and ATEX reference directives

## Commitment focused on reducing the environmental impact and protecting occupational health and safety, through:

- The definition, formalization and dissemination of this Policy

- The definition and achievement of environmental and safety improvement objectives

- The identification and assessment of the environmental effects and risks due to accidents, accidental facts, potential emergency situations relating to both the products and the production process

- The retrieval of rules and laws, the management of regulatory updates, the study of their applicability and strict compliance with them, as well as the use of "best practice" rules

- The continuous improvement of its organizational and technical skills capable of reducing the environmental impact and the risks associated with its activities

- The control of its supply chain, not only from a qualitative point of view but also from an environmental and safety point of view

- The reduction of the environmental impact, the prevention of accidents and occupational diseases, the elimination of dangers and the reduction of risks and risk factors for the safety of personnel involved in various capacities in company activities

- Continuous adaptation to the growing needs in the field of environmental protection and safety, addressing them where possible through adequate planning of activities and initiatives in these fields

- Raising the awareness of personnel within the company and of external parties involved in the activities of OFFICINE OROBICHE, through the dissemination of knowledge and of the problems of environmental protection and safety and of the technical and organizational disciplines

- Continuous information and training actions in the field of safety for all personnel
